FOOD SCARCITY AND LIVELIHOOD. STAGNATION AND AGONY OF TRAVELLING TO SOUTH EXPERIENCED BY THE VANNI PEOPLE.

Due to the scarcity of food the entire Wanni population are facing a serious starvation and death this unholerable situation continues without any solution. Hence, to bring this disaster to your kind perusal, we have dicided to conduct huge prosessions on behalf of our welfare Organization on the same day it self in both districts. One is at Tharmapuram in Kilinochchi district and the other at three places like Puthukkudiyiruppu, Oddusuddan and Mullaitivu in Mullaitivu district and submitting this petition to you on behalf of our people.

We are submitting this petition to your excellency on behalf of the society that maintains the welfare of the Wanni people. In order to bring forward tha realism and to create awareness among the entire nations interested in human rights, about the cunnig approch of the Srilankan government by means of various activities such as using supplies of food, Medicines and other inputs as weapons upon the innocent people.

Our Wanni welfare society is formed as a civil society to express it's civil rights belongs to the civil communities to the developping world. Representatives of varrious communities are included in this society. At this stage, these requests are being expressed inorder to show the planned activities carriedout very recently by the Srilankan government and it's military machineries against the civilions in our region.

FOOD AND IT'S DISTRIBUTION.

- Transportation of food items have to be done by Lorries only.
- But the security forces are purposely reducing the number of lorries that are allowed by the government.

You must understand this situtation. Some details are given below for your information.

- Though the quantity and chromology of the distributions of the basic food items already decided and arranged by the UN for the displaced to ensure there food security. Preventing the distributions by means of blocking the lorries and as the result the back feeding in the WFP distributions chromology are not delivered. Hence, the situation of the people are very pathetic, looking at their food-stamps and unable to receive there food items continues.
- The food items worth of Rs.1260/= only issued by the Commissioner of Essential Service Department to an IDP family consisting five (05) members per month. This quantity was fixed in the year 1983. But the govt, doesn't change this amount even the cost of living is very high due to the price escalation during the past two decadec. And also, these items were not issued correctly.
- Even the Transportation of food items such as juggary tamarind and dates are completely prohibited. Also banning of nourishment food items continues timeto time.
- Among the non food items such as building materials, dresses, inputs, took, vechiles and machineries are completely restricted. At this position we under the impression, whether we are not citizens of a democratic country and your excellency must realise at we are a society to whom basic need of dress is completely rejected.

FUEL.

- Transportation of electricity, pettrol, deasel Oil and tar in to the Vanni region is Complefely banned.
- For the population of more than four hundred thousands living in this region only kerosene oil is allowed as one and the only fuel. This is also because it is refined from the crude oill as a sub item and unable to sell it in other parts of the country. Several restrictions and ruductions have been made in this transportation. while transporting it even with the authorised permision. We are faching several restrictions and reduction. To show the realism the details are givin below for your kind perusal.

In this case Kerosene oil had been issued to the displace people staying in Kilinochchi and Mullaitivu districts from Mannar and Vavuniya districts out of the keresene oil reseived for our two districts. And also the displaced MPCSS are functioning here, but they are not reseving none of the fuel allocation.

SHELTERS FOR DISPLACED PEOPLES

In Vanni due to the occurrence to the worst human disaster and inland displacement, so for 74042 families consistoing of 275,000 persons (Seventy Four thousand forty two families – Two hunderd and Seventy five thousand members) have been displaced and staying under the trees and temporary sheltasrs. All the INGOOs functioned, in the Wanni region had vaccated from this area according to the pre- planned intructions of the government. At this stage, no actions have been taken, to provid shelter facilities to these suffering people, but in case if the same thing happens, in South of Sri-lanka the relief neasures will be taken immediately without any delay. This indicates the stepmotherly treatment very clearly.

Definitely a solution must be found to this human disaster, and also must come forward immediately to avoid the people affected by the diseases and snake bites.

AGRICULTURE INPUTS.

Almost 75% of the people living in wanni are traditional farmers, depending mainly on cultivation it is an agricultural area consisting 8509 hectres of paddy cultivatable land and 3476 hectres of vegetable and other Crops cultivatable land. Most of the people's Lands are deserted, due to the ongoing displacements. Though their needs of vegetables and other food Crops are managed from the local products. At this situation, due to the restrictions imposed on transporting agric inputs such as fertilizer and germicides and preventing the production, have made several families lost their main occupation and income and therefore we would like to express their loss of purchasing power to your Excellency.

FISHING INDUSTRY.

Fishing is the secondary livelihood activity of Wanni population. But, due to the safely zones laws implemented by the Military the deep sea fishing is completely prohibited The fishermen society had become a poor community as they are unable to do their fishing due to the cannon attacks frequently taking place along the coastal areas. The government has restricted the transportation of any kind of fishing inputs into this area.

HEALTH SERVICE.

Transportation of medical items to be kept in the hospitals for the health care of Wanni population are restricted heavily. Many doctors have been killed while taking the patients for urgent treatment due to the claymore attacks. The govt. Servants and the doctors are traveling at their own risk with fear. Important medicals to safeguard the lives specially the snake bite medicines are not allowed, it seems.

EDUCATION SECTOR.

The educational development activities implemented by the govt. in various parts at this country such as issue at free school books, school uniforms are not carried out in our area properly and orderly. These free delivery items are unable to transport from South to this area due to the restrictions on Lorries and roads. As our students have to appear for the National Level Examination although there are delays in completing their subjects syllabuses they are unable to reach their targetted level due to the scarcity of these inputs.

UNSAFETY ROAD TRANSPORT.

The number of people travelling from Wanni had been decreased due to the frequent closure of the exit/entry point, harassment at security forces while checking and strict inspections on persons and vehicles. The guarantee must be given to the lives of the govt. employees convey officers and vehicle drivers as they are facing claymore attacks along the traveling route while travelling.
