MOTION AGAINST SRI LANKA AT GENEVA HUMAN RIGHTS SESSIONS, MARCH'13

IT IS REPORTED IN THE MEDIA THAT YOU HAVE VOWED TO SEE THAT THE MOTION AGAINST SRI LANKA SCHEDULED TO BE TAKEN UP AT THE MARCH SESSIONS OF THE UNHRC IS NOT CARRIED THROUGH.

YOU WOULD NOT HAVE MISSED THE PHOTOGRAPHS OF BALACHANDRAN, THE 12 YEAR OLD SON OF LTTE LEADER PIRABAKARAN MUNCHING SOMETHING IN A BUNKER IN A COOL AND CALM CONDITION AND THEN LYING DEAD WITH FIVE GUN SHOT INJURIES FIRED AT CLOSE RANGE. HE WAS ARERSTED ALIVE DURING THE LAST STAGES OF THE GENOCIDAL WAR IN 2009 AND THEN KILLED FOR THE SIMPLE REASON THAT HIS BIOLOGICAL FATHER IS THE LTTE LEADER PIRABAKARAN. IT IS A UNIVERSAL CODE OF ETHICS IN WARFARE THAT WOMEN AND CHILDREN SHALL NOT BE KILLED – HERE HE S JUST 12 YEARS OLD. HOW WILL YOU FEEL IF HE WAS YOUR GRANDSON? ARE OUR BELIEFS THAT RUSSIA IS A CHAMPION OF THE DOWNTRODDEN AND OPPRESSED A FALSE DREAM. DO YOU WANT THE TAMILS WIPED OUT?

PLEASE SEARCH YOUR CONSCIENCE AND LET THE WORLD KNOW IF YOU ARE REALLY COMMITTED TO SAVING THE CULPRITS RESPONSIBLE IN THIS KILLING OR WHETHER SRI LANKA IS MISQUOTING YOU. THIS IS AN EARNEST AND SERIOUS REQUEST. YOU CAN OPT TO BE SILENT BUT THAT WOULD BE TANTAMOUNT TO ADMISSION OF SRI LANKA'S CLAIM. PLEASE DO SO THROUGH YOUR MEDIA IN MOSCOW AND PLEASE CONVEY IT TO ME THROUGH YOUR EMBASSY IN WELLINGTON, NEW ZEALAND. I AM AWAITING YOUR REPLY NOT LATER THAN MONDAY 25 FEBRUARY.
