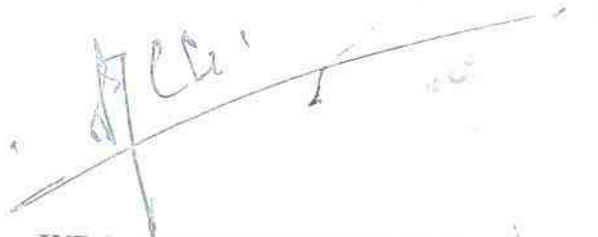
Heard both counsel in support of their respective cases. We are not inclined to grant leave to proceed in this case. Leave to proceed is refused. Petition is dismissed.
